- 4.2 <u>Managing Trustee/Chairman:</u> Sri. H.K. Javaregowda shall be the Managing Trustee/Chairman of the Trust. The Trust is at liberty to have such other office bearers as deemed fit by them. Such change in office shall however be made by way of a resolution.
- 4.3 Secretary & Treasurer: The Secretary & Treasurer would be Sri. Gowtham J and Smt. Shobha J Gowda respectively. The said office is for life. The remuneration to the office bearers shall be paid in terms of the resolution of the trust.
- 5. Powers to appoint Agents & Committees: The Board of Trustees shall be entitled to appoint Agents & committees with or without removal and on such terms and conditions as they think proper, persons or agents and committees for proper management of the functions of the Trust and the institutions established by the Trust Committee. The Persons/agents shall function under the overall control of the Trustees.

OPERATING BANK ACCOUNTS: The Board of Trustees can delegate to or any of its functions in favour of the Agents and committees and can also authorize these persons to carry out bank transaction. The Board of Trustees can authorize its agent I committees / persons to withdraw or credit amount, to open bank accounts and to carry out financial transactions subject to overall supervision of the Board of Trustees. The Board can also delegate all or any of its functions by constituting a committee or in favour of a specified person.


POWER TO SELL THE IMMOVABLE PROPERTY & MANAGE: The Board of Trustee may sell or assign any movable or immovable properties by public auction or private contract and the money arising out of the same shall be used for the purpose of trust. The trustees shall use all trust properties for carrying out the objectives of the trust The trustees can take all action necessary to safeguard, protect, acquire, immovable or movable properties and can also initiate legal action including arbitration for protection, safeguarding the trust property and its functions.

- RULES: The Trustees can formulate rules for better management and administration of trust activities and any rules can also be amended, modified or repealed by the trust by a resolution.
- a) <u>AMALGAMATION:</u> The Trustees shall be at liberty to amalgamate other trust institutions without anything adversely affecting the objectives of the Trust.
 - b) <u>DIVERSIFICATION</u>: The Trustees shall be at liberty to start any other educational/social/scientific institutions, implement projects and programs for rural development, skill development, environment and animal welfare and keeping in mind the objects of the trust. The trustees are at liberty to give such names of their choice to such institutions, projects and programs.
- GENERAL: The Board of Trustees would be competent to empower to do all such things as may be required for the fulfillment of the objectives of the Trust.




- c) The Chairman shall convene the meetings of the Trust and the other units through the Secretary as per rules.

13.2 Powers and Duties of the Secretary:




- He shall convene all meetings of the Trust on due dates and give b) intimations thereof to the members in time.



13.3. Powers of Treasurer:

- d) To borrow money with or without security and to repay the same and for this purpose the Board shall have power to sign such promissory notes, bills of exchange, hundis or any other documents that may be necessary for and on behalf of the Trust.
- e) To receive, collect and enforce recovery of all moneys due or payable to the Trust and grant necessary receipts and discharge therefore and such receipts of the Board shall effectively discharge the persons paying the amount due to the Trust.
- d) To settle, compromise or compound all or any debts, claims, outstandings, accounts, disputes, demands, actions, suits and proceedings whatsoever by or against or relating to the Trust or refer the same to arbitration.
- g) To authorize, make, alter and/or rescind the rules and regulations for the management and administration of the Trust.
- b) To raise donations or accept gifts or contributions in cash or in kind without any onerous conditions attached thereto from any person for the purpose of the Trust.

- i) To receive voluntary contributions from any person/s whatsoever by way of donation, legacy and gifts and to hold the same upon trust for the benefit of Beneficiary herein in the aforesaid shares and subject to the powers, provisions and stipulations set-out herein.
- j) In addition to the powers and rights specifically stated above, the Board shall have all such powers as are necessary for the purpose of attaining the objects of the Trust.
- k) The Board of Trustees shall have power to delegate all or any of the powers conferred on them to any person/s and from time to time vary such powers and such person/s shall have all such power so delegated to him/her/them. The Board shall also have power to revoke all or any of the powers delegated by them.
- 14. The Board of Trustees shall have no power to invest the funds of the Trust in any business which is of speculative nature or which is in the nature of gambling.



18. MEETING AGENDA QUORUMI

- 18.1 Meetings All the meetings of the Trust shall be called by the Secretary under the direction of the Chairman.
- 18.2 Decisions at a meeting of the Trust shall be by a majority of vote
- 18.3 At least seven days previous notice of meeting shall be given to members for ordinary meeting and a day's notice for emergency meeting, provided that in case of urgency, if the Chairman so thinks fit, a resolution can also be passed by circulation.
- 18.4 In case the votes are equal, the Chairman shall have a casting vote.
- 18.5 One-third (1/3rd) of the Board of Trustees would be the quorum for any meeting.
- 18.6 One of the meetings would be called Annual General Meeting in which the audited statement of accounts would be presented before the meeting for its approval.





19. AMENDMENTS:

No amendments to the Trust deed and rules and regulations of the tat shall be made which may prove repugnant to the provisions of the section 2(15), 11, 12, 13 and 80-G of the Income tax Act 1961. Further no amendments shall be carried over without the prior written approval of the Commissioner of Income Tax. However, the trustees and the General body is at liberty to carry out such amendments within the framework of law and which are not repugnant to the objects of the trust.

20. <u>IRREVOCABILITY:</u> This trust is irrevocable and any of the property of Trust will never be reverted back either to the Authors or to the Trustees.

 FUNDS OF THE TRUST: The funds of the trust shall be solely utilised towards the achievement of the objects and no portion of it shall be utilised for payment to trustees by way of profits, dividends etc.,

 BENEFITS OF THE TRUST: The benefits of the trust shall be open to all people irrespective of the caste, creed or religion.
